ORDINANCE NO. 820

AN ORDINANCE AUTHORIZING THE PURCHASE OF A 2023 DODGE DURANGO PURSUIT

WHEREAS, the City of Assumption (hereinafter “City”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/2-3-8, empowers the City to contract, acquire and hold personal property for corporate purposes; and

WHEREAS, the City utilizes a fleet of vehicles to perform routine municipal functions throughout the City; and,

WHEREAS, the City has determined that the City Police Department is in need of a new police vehicle suitable for its uses, such as a Dodge Durango Pursuit; and

WHEREAS, the City has received a quote for a 2023 Dodge Durango Pursuit that is suitable for the City’s uses and is available from Victory Lane Chrysler Dodge Jeep Ram of Carlinville, Illinois, for a base selling price of less than \$45,000; and,

WHEREAS, the Mayor and the City Council believe it is in the best interest of the City to purchase the referenced Dodge Durango Pursuit on the terms described above.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ASSUMPTION, CHRISTIAN COUNTY, ILLINOIS, as follows:

Section 1. The above recitals are incorporated into this Section 1 and made a part hereof by this reference.

Section 2. Purchase of Personal Property. The City hereby authorizes the Mayor to accept a bid for a 2023 Dodge Durango Pursuit for a base selling price not to exceed \$45,000 and a total selling price not to exceed \$50,000, plus fees for municipal plates, and the Mayor and City Clerk are hereby authorized to execute any documents required to consummate the purchase contemplated by this Ordinance on behalf of the City.

Section 3. If any provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this Ordinance.


Section 4. All ordinances, resolutions, motions or orders in conflict with the provisions of this Ordinance are hereby superseded to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect immediately upon its adoption.
