**ORDINANCE NO. 835**

**AN ORDINANCE AUTHORIZING CITY EXPENDITURES PENDING ADOPTION OF  
AN ANNUAL APPROPRIATION ORDINANCE**

**WHEREAS**, the City of Assumption, Christian County, State of Illinois, ("City") is a duly organized and existing city created and operating under the provisions of the Illinois Municipal Code and laws of the State of Illinois; and,

**WHEREAS**, the appropriation ordinance for fiscal year May 1, 2025 to April 30, 2026, has not been enacted by the corporate authorities of the City; and

**WHEREAS**, pending the passage of such annual appropriation ordinance, the corporate authorities of the City have authority to and may make any necessary expenditure upon the basis of the appropriations of the preceding year, as authorized by Section 8-1-7 of the Illinois Municipal Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF ASSUMPTION, CHRISTIAN COUNTY, ILLINOIS**, as follows:

**Section 1.** The Recitals set forth above are hereby incorporated in this Ordinance as if fully set forth herein.

**Section 2.** Authorization. Pending the passage of the annual appropriation ordinance for fiscal year May 1, 2025 to April 30, 2026, heads of departments or other agencies of the City are hereby authorized, beginning May 1, 2025, to make necessary expenditures for the support thereof upon the basis of the appropriations of the preceding fiscal year.

**Section 3.** In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest

extent permitted by law.

**Section 4.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the City of Assumption prior to the effective date of this ordinance.

**Section 5.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
